**VOLUNTARY ANNOUNCEMENT IN RELATION TO
THE PUBLICATION OF THE 2025 THIRD QUARTERLY REPORT
BY ANHUI CONCH CEMENT COMPANY LIMITED**

This announcement is made by China Conch Venture Holdings Limited (the “**Company**”, which together with its subsidiaries are collectively referred to as the “**Group**”) on a voluntary basis.

As at the date of this announcement, the Group is directly interested in 49% equity interests in 安徽海螺集團有限責任公司 (Anhui Conch Holdings Co. Ltd.*, “**Conch Holdings**”), which in turn is interested in approximately 36.40% equity interests in Anhui Conch Cement Company Limited (“**Conch Cement**”, Hong Kong Stock Exchange stock code: 00914, Shanghai Stock Exchange stock code: 600585). As disclosed in the Company’s annual report previously published for the year ended 31 December 2024 (“**FY2024**”) and its interim report for the six months ended 30 June 2025 (“**1H2025**”), the Group derived a substantial portion of its profit for FY2024 and 1H2025 from its equity interests in Conch Holdings, an associate of the Company. During such periods, the share of profit of Conch Holdings accounted for approximately 64.9% and 65.3% of the Group’s profit, respectively.

Having taken into account the above factors, the board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company that Conch Cement published its 2025 third quarterly report (the “**Conch Cement 3Q2025 Report**”) containing its unaudited quarterly results for the nine months ended 30 September 2025 on 30 October 2025.
